Dr. Richard Rawson has spent the past 34 years conducting research and developing systems for treating individuals with substance use disorders. He received his Ph.D. from the University of Vermont, is currently an Adjunct Associate Professor in the UCLA Department of Psychiatry and the Associate Director of the UCLA Integrated Substance Abuse Programs. He is also the principal investigator of the National Institute on Drug Abuse (NIDA) Methamphetamine Clinical Trials Group, and is Co-PI of the Pacific Node of the NIDA Clinical Trial Network. During the past decade, he has worked with the US State Department to export US technology and addiction science to Mexico, Thailand, Israel, Egypt and South Africa. Dr. Rawson has published 2 books, 20 book chapters and over 150 professional papers and has conducted over 1000 workshops, paper presentations and training sessions.

Driving Directions:

From the West: Take I-74 East to I-55, go South to Exit 160-B, Route 9 (Market Street). go West 3/4 mile; turn right into the Interstate Center.

From the East: Take I-74 West to Bloomington-Normal, IL and meet I-55 North; take I-55/74 to Exit 160-B; go West on IL Route 9 for 3/4 of a mile; turn right into the Interstate Center.

From the North via I-55: Take I-55 South to Exit 160-B, West on Route 9 (Market Street); go 3/4 mile; turn right into the Interstate Center.

From the North via I-39: Take I-39 South to I-55 at Bloomington-Normal; take I-55 South to Exit 160-B, West on Route 9 (Market Street); go 3/4 mile; turn right into the Interstate Center.
